# 4.2 Land Use Bylaw Update

Ermias Amayu, Breena lannetti, and Such Chandhiok, Planning and Development Services, presented an update on the Land Use Bylaw speaking to the proposed changes to the Bylaw as well as next steps being undertaken with the goal of implementing a new bylaw in 2025.

Committee members provided feedback regarding the proposed changes and through consensus, agreed to defer a decision on whether or not a letter of support for the bylaw would be provided until a further update is received following community engagements held and feedback being incorporated in the document.

#### 4.3 Round Table

K. Meacher, Organizational Support Services, provided the following updates:

- contamination remediation work will be part of construction on the site proposed for the shipyard relocation;
- should Clearwater Drive remain as is, building the permanent berm to 250.9 m would eliminate the line of sight to the Clearwater River;
- land sale of the old A&W site was completed on March 13, 2024, and closed on May 1, 2024. The developer is proposing to construct a medical complex and anticipated construction start is June, 2025;
- Hawker boxes have arrived for set up in Kiyām Community Park.
