# Recommendation(s):

THAT the Q1 2024 Flood Mitigation Update be accepted as information

## Summary | Background:

This report continues to utilize the Flood Mitigation Framework (the "Framework") that was introduced on May 23, 2023, and provides an update on the progress of Flood Mitigation as well as financial reporting.

### Background:

The Framework was developed to enhance transparent financial reporting, create measurable completion milestones, and create a shared understanding of the projects and activities associated with flood mitigation. The Framework is accompanied by a cross-departmental working group that shares decision-making and supports multiple projects moving forward concurrently. The Framework's stages are:

- Stage 1: Original 2014 Flood Mitigation Program
- Stage 2: Post-2020 Flood Modifications and Expansion

Stage 3: Mitigation Integrity Review

### Program Update by Stage:

### Stage 1: Original 2014 Flood Mitigation Program

Since the last update on April 9, 2024, progress on Stage 1 projects continued with active construction on Reaches 5, 10-1 and 11. These Stage 1 projects remain on schedule, as identified within the Framework.

#### Reach 5

As of this reporting period, the contractor has completed the installation of the Z bracing, and the installation of the pile caps is ongoing. Additionally, the installation

of live staking (bioengineering measure) as a form of erosion control is in progress and the top-up of areas in the berm that have settled is taking place. It is anticipated that substantial completion for the project will be the end of the 2024 construction season.

#### Reach 6

A detailed presentation on proposed design options is scheduled to be presented to Council on July 9, 2024, for decision of the final design. Tender for construction is anticipated for 2025 with construction planned to begin in 2026.

#### Reach 10-1

Project is 93% complete with outstanding deficiencies expected to be completed by the end of the 2024 construction season.

#### Reach 10-2

The design scope for Reach 10-2 is currently being finalized with tender planned for late 2024/early 2025, and construction to occur thereafter.

Mitigation is complete for Reaches 7, 8 and 11.

#### Stage 2 - Post-2020 Flood Modifications and Expansion

#### Seasonal Mitigation

As permanent flood mitigation continues to progress, the requirement for seasonal mitigation decreases. Overall costs have trended downwards over the last 3 years, as shown in the following chart:

#### Interim Mitigation

The interim clay berms that run alongside portions of Clearwater Drive will remain in place until construction starts on Reach 6. This berm continues to be monitored

and inspected on an annual basis to ensure that the protection level of 250.0m is achieved.

## TaigaNova North

Construction has now begun on TaigaNova North, anticipated completion date is the end of the 2025 construction season.

#### **Underground Enhancements**

The contract for underground enhancements is on schedule to be executed in Q3 2024. The contract includes enhancements to Reaches 1-4 Storm Outfalls (the Athabasca Bridge Storm Outfall and the King Street Bridge Storm Outfall) and the Sanitary System enhancement at Borealis Park. Construction is expected to begin in the coming weeks with completion anticipated to be by the end of the 2025 construction season.

Reach 3 enhancements were added to the Underground work scope, which will include an earth berm and an elevation increase to the Father Mercredi Street parking lot. Raising the intersection at Hardin Street and Clearwater Drive will be combined with other work activities planned for this area and will be tendered separately.

### Hangingstone Expansion Area

Hangingstone Expansion Area was prioritized after the June 2023 high water event. Design work is to begin in 2024 with construction anticipated to begin in 2026.

### TaigaNova South

TaigaNova South is in the pre-design phase. Design is anticipated to be finalized in 2024 and construction anticipated to begin in 2025.

### Reaches 1-4 & 9 Enhancements

Work on the Reaches 1-2 and 9 designs has not yet begun.

Reach 3 Enhancements has been combined with Underground Enhancements, with work anticipated to begin in 2024.

Reach 4 Enhancements is in the design phase and is anticipated to be finalized in late 2024/early 2025.

## Stage 3 - Mitigation Integrity Review

Budget for design was approved during the budgeting process in December 2023 for work to begin on the Reach 8 Bank Stabilization project. Preliminary preparation has also begun for an assessment of the Saline Creek Parkway Traffic Bridge.

## **Budget | Financial Considerations:**

The financial reporting for costs related to flood mitigation activities will continue to be presented by reach and/or project area on a regular basis. A financial overview broken down by stage, along with a breakdown of annual total spend since 2014, are found below.

All financial reporting in this report is current as of March 31, 2024.
